This letter serves as a formal justification for procuring specialized mechanic services for the Eaglecrest Ski Area fleet of PistenBully snowcats on a sole source basis from Kässbohrer All Terrain Vehicles, Inc. (KATV).

As a service manager for KATV, I can confirm that we are the exclusive provider of factory-direct parts, specialized tools, proprietary diagnostic software, and manufacturer-certified mechanic expertise necessary to maintain the integrity, safety, and operational readiness of your specialized snowcat fleet.

1. Description of Required Services

Eaglecrest Ski Area requires preventative maintenance, diagnostics, and repairs for its Kässbohrer snowcats (e.g., PistenBully models). 2. Justification for Sole Source Procurement

- **Exclusive Access to Factory Parts:** As the Original Equipment Manufacturer (OEM), we are the only source for authentic, warrantied replacement parts. Using non-OEM parts can compromise machine performance, safety compliance, and void any remaining factory warranties.

3. Conclusion

For the reasons outlined above, Kässbohrer All Terrain Vehicles, Inc. is uniquely and solely qualified to provide the necessary mechanic services for the Eaglecrest Ski Area snowcat fleet. We request approval to proceed with the procurement of these essential services on a non-competitive, sole source basis.
