RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION OF THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU REINSTATING THE CITY AND BOROUGH'S PETITION FOR ANNEXATION OF CERTAIN ONSHORE AND OFFSHORE AREAS IN STEPHENS PASSAGE AND ADMIRALTY ISLAND TO THE CITY AND BOROUGH OF JUNEAU AND RESCINDING THE ASSEMBLY'S ACTION WITHDRAWING THE PETITION SUBJECT TO THE CONDITION THAT THE OPERATIVE DATE OF THE ANNEXATION BE DEFERRED UNTIL JANUARY 1, 1994.

WHEREAS, on June 1, 1989, the City and Borough of Juneau submitted a petition to the Department of Community and Regional Affairs for the annexation of certain onshore and offshore areas in Stephens Passage and Admiralty Island to the City and Borough of Juneau, as authorized by Resolution No. 1382, and

WHEREAS, on July 13, 1990, the Assembly adopted a motion to withdraw the annexation petition, and

WHEREAS, on July 13, 1990, the Local Boundary Commission held a hearing in Juneau on the annexation petition and the ideal boundary study for the city and borough prepared by the Department of Community and Regional Affairs, and

WHEREAS, on July 14, 1990, the Local Boundary Commission approved the annexation petition as submitted by the city and borough contingent upon the Assembly adopting a resolution by August 28, 1990, reinstating the petition and rescinding the Assembly's action to withdraw the petition, and

WHEREAS, the Assembly has again considered this issue and has determined that, subject to the condition set forth in paragraph 3 below, the annexation petition as submitted by the city and borough and as approved by the Local Boundary Commission would be in the best interests of both the city and borough and the territory to be annexed;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That the annexation petition submitted by the City and Borough of Juneau to the Department of Community and Regional Affairs on June 1, 1990, for the annexation of certain onshore and offshore areas in Stephens Passage and Admiralty Island to the City and Borough of Juneau, as authorized by Resolution No.

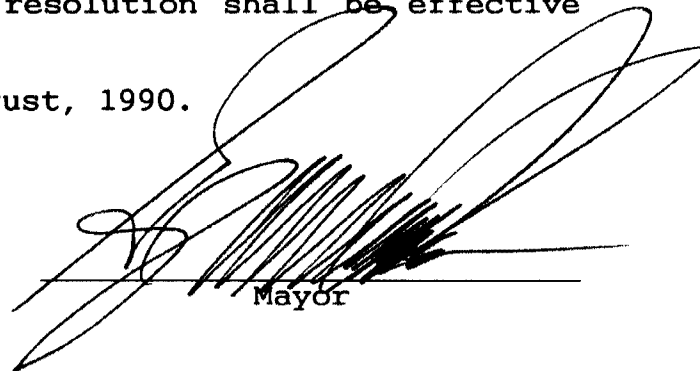
1382, is hereby reinstated subject to the condition set forth in paragraph 3 below.

2. That the action taken by the Assembly at its special meeting on July 13, 1990, to withdraw the annexation petition is hereby rescinded.

3. That the city and borough's reinstatement of the annexation petition is subject to the condition that the Local Boundary Commission include in its decision approving the proposed annexation, a provision that the operative date of the annexation shall be January 1, 1994.

4. Effective Date. This resolution shall be effective immediately upon adoption.
