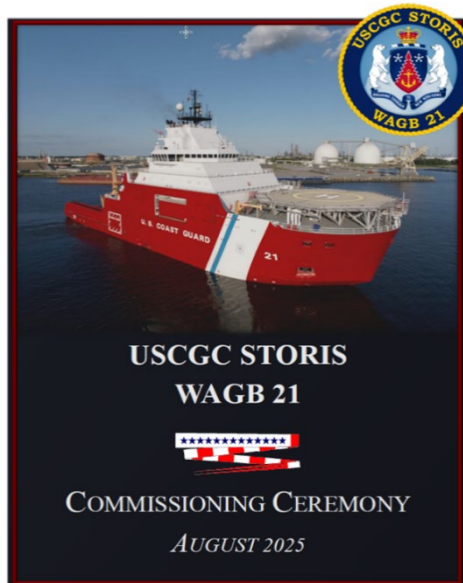

**Port Director's Corner:** On August 10th, the US Coast Guard will commission the Cutter STORIS (WAGB 21) in Juneau. This is the first icebreaker acquired by the US since the USCGC HEALY in 1999. STORIS was built in Louisiana by Edison-Chouest Offshore for Royal Dutch Shell in support of Shell's drilling operations in the Beaufort Sea and Chukchi Sea. It was originally named M/V AIVIQ, which means "walrus" in the Inupiaq language. The \$150 million contract for the construction of an icebreaking anchor handling tug supply (AHTS) vessel was completed in 2011.

The original STORIS (WMEC 38), constructed in 1942, was an ice patrol tender and initially assigned to the North Atlantic during World War II, primarily participating in the Greenland Patrols. STORIS became the first U.S. registered vessel to circumnavigate the North American continent in 1957. She was homeported in Kodiak and in Juneau as was affectionately known as the "Galloping Ghost of the Alaskan Coast," with a storied history conducting icebreaking operations in Alaska and the Arctic. Storis is a Scandinavian word meaning "great ice".

Following the STORIS (WAGB 21) commissioning, she will conduct Arctic operations and return to the temporarily homeport of Seattle awaiting infrastructure improvements to Coast Guard facilities in Juneau. Recent federal appropriations have directed \$300M in funds for Juneau for shore support and other funding to construct approximately 17 other icebreakers.



**Docks & Harbors Board:** At the July 31st annual Board Meeting, Shem Sooter was elected as the new Board Chair and Jim Becker was appointed as Vice Chair. Nick Orr was elected as Chair of the Operations-Planning Committee with Mark Ridgway being the Vice Chair of that committee. The Board welcomed Robert Horchover as a new member as well as Mark Ridgway who returned to the Board. **Statter Harbor Phase IIID Update:** Statter Harbor Phase IIID. Dawson Construction continues to make great progress in the project to add curb, gutter, lighting, landscaping and paving. Paving for additional truck and trailer parking spots were finished before Salmon Derby Weekend. Dawson is on schedule to have the lot repaved by October.
