ONLINE PORTAL NAME RESTRICTION REQUEST

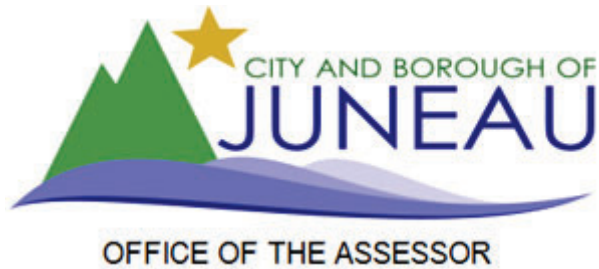
The City and Borough of Juneau Assessor's Office publishes assessment and ownership information for all borough parcels on the Assessor's Office webpage (Juneau.gov).

While ownership and assessment information remain a public record accessible by anyone upon request, the owner of record of property in the borough may request the ownership information be removed from web publication. The process for requesting the removal of ownership information is as follows:

- The owner must make the request in writing to the Assessor. At minimum, the request must include the name of the requestor(s), all parcel numbers for property owned by the requestor, and original signature(s) of all record owners for each parcel.
- The Assessor will review each request and communicate to the requestor whether the request has been approved.
- Upon approval by the Assessor, staff will remove all owner names and mailing address information available through the online portal but will continue to publish parcel data with online mapping.
- Any recorded deeds affecting ownership or vesting will require a new request by the Grantee stating their desire to block ownership information from online public portals.
