RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION ESTABLISHING THE FEES  
FOR ANIMAL CONTROL SERVICES.

WHEREAS, CBJ 08.05.070 provides that the Assembly by resolution shall establish fees for services provided under the animal control code, and

WHEREAS, Resolution No. 1149 as amended by Resolution No. 1381, established fees for impoundment, boarding, licensing, and other services performed under the animal control code, and

WHEREAS, the Gastineau Humane Society has reviewed these fees and has recommended an increase in the dog license fee, and

WHEREAS, the Assembly has reviewed this recommendation and has determined that the proposed fee change is warranted at this time;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

\* Section 1. Animal Control Fee Schedule. Pursuant to CBJ 08.05.070, the following fees shall be charged for services provided under the animal control code:

(a) Dog License Fees. The annual license fee shall be \$25.00 for each dog over the age of six months, provided that the fee shall be \$10.00 for each spayed female and neutered male over the age of six months, and provided further that the fee shall be reduced by one-half for dogs acquired after September 1 of the calendar year and for dogs which attain the age of six months after that date. A late fee of \$10.00 shall be added to all license fees for licenses issued after March 31 unless the dog is under six months of age or the owner has relocated to the city and borough within the last thirty days.

(b) Kennel License Fees. The annual license fee for a kennel shall be \$100.00.

(c) License Transfer Fee. The fee for the transfer of a dog or kennel license shall be \$2.50.

(d) Duplicate Tag Fee. The fee for the issuance of a duplicate of a lost license tag shall be \$5.00.

(e) Impound Fee. The fee for impoundment shall be as follows:

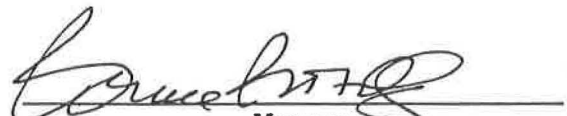

(f) Impound Boarding Fee. The fee for boarding an impounded animal shall be \$7.50 per day or any portion of a day until the owner of the animal is contacted, at which time the fee shall increase to \$15.00 per day or any portion of a day, including the day the owner is contacted. For purposes of this section, a day shall be the period of time from midnight to midnight.

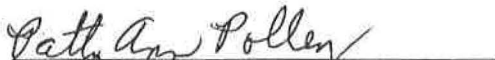
\* Section 2. Repeal of Resolutions. Resolution Nos. 1149 and 1381 are hereby repealed.
