

**PROPOSITION NO. 1**  
**EXPLANATION**

This proposition assesses a fee of five dollars (\$5), per passenger for each passenger ship not otherwise exempted. The passenger fee for each ship shall be calculated based on the passenger manifest for the ship upon entry into any port within the City and Borough of Juneau.

Exempted from this fee are ships having accommodations for forty or fewer passengers; ships without berths or overnight accommodations for passengers, and; noncommercial ships, ships operated by non-profit entities as determined by the United States Internal Revenue Service or ships operated by the state, the United States of America, or a foreign government.

Passenger fees shall be paid to the City and Borough of Juneau. Funds collected are not dedicated.

**PROPOSITION NO. 1**  
**CODE AMENDMENT**

Shall a fee of five dollars (\$5), per passenger be assessed for every marine passenger ship not otherwise exempted? (Exempted from this fee are ships having accommodations for forty or fewer passengers; ships without berths or overnight accommodations for passengers, and; noncommercial ships, ships operated by non-profit entities as determined by the United States Internal Revenue Service or ships operated by the state, the United States of America, or a foreign government.) The passenger fee for each ship shall be calculated based on the passenger manifest for the ship upon entry into any port within the City and Borough of Juneau.

**PROPOSITION NO. 2**  
**GENERAL OBLIGATION BONDS**  
**(HIGH SCHOOLS), 1999**  
**\$62,900,000**

For the purpose of paying the cost of renovating Juneau-Douglas High School and constructing and equipping a new high school at Dimond Park, shall the City and Borough of Juneau, Alaska, issue and sell its general obligation bonds, maturing within 15 years of date of issue, in the principal sums as follows:

- not to exceed \$62,900,000 for total costs of both projects if the projects qualify for 50 percent or more State reimbursement of the related bond debt service at the time the bonds are issued; or
- not to exceed \$3,000,000 for initial design of both projects and site preparation for the Juneau-Douglas High School project if the projects do not qualify for State reimbursement at the time the bonds are issued?

Assuming the bonds are issued in the principal amount of \$62,900,000, mature over a 15-year period and bear interest at an average rate of 5.5% per annum, the estimated total cost of renovating Juneau-Douglas High School (including estimated total interest on the bonds) is \$19,427,100. The annual operation and maintenance cost of the existing Juneau-Douglas High School is approximately \$1,859,000 (not paid from bond proceeds). The City and Borough of Juneau does not anticipate that the annual operation and maintenance costs of the Juneau-Douglas High School will increase as a result of the proposed renovations to the high school. Assuming the bonds are issued in the principal amount of \$62,900,000, mature over a 15-year period and bear interest at an average rate of 5.5% per annum, the estimated total cost of constructing the high school (including estimated total interest on the bonds) is \$74,569,800. It is estimated that the annual operation and maintenance cost of the new high school at Dimond Park will be \$1,668,000 (not paid from bond proceeds).

Under current statutes, certain school projects may qualify, in whole or in part, for 50 percent or more reimbursement of the related bond debt service. The funds available for the reimbursement program are subject to annual appropriation by the Legislature. If the Legislature fully funds the debt reimbursement program, it is estimated that the City and Borough of Juneau would receive a minimum of \$37,735,100 from the State of Alaska and the city would pay no more than \$56,261,800 of the remaining debt service. It is estimated that, if the bonds are issued in the principal amount of \$62,900,000 and if the State of Alaska fully funds the debt reimbursement program, on a property with an assessed value of \$100,000, annual taxes in the amount of \$152 would be required to retire the debt. If the projects to be financed with bond proceeds do not qualify for State reimbursement at the time the bonds are issued, the aggregate principal amount of such bonds shall not exceed \$3,000,000. It is estimated that, in such event, the estimated total cost of the bond-financed projects (including estimated total interest on the bonds) is \$4,483,200 and that, on a property with an assessed value of \$100,000, annual taxes in the amount of \$12 would be required to retire the debt.
