## RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

### Serial No. 1812

#### **A Resolution Establishing the 1996 Port Dues for the City and Borough of Juneau Port Facilities, and Repealing Resolutions 1753 and 1754.**

WHEREAS, Resolution Serial No. 1753, adopted on March 20, 1995, established the current schedule of fees and charges for the city and borough small boat harbors, and

WHEREAS, Resolution Serial No. 1754, adopted on March 20, 1995, established the current schedule of fees and rates for the city and borough port facilities, including the port dues, and

WHEREAS, CBJ 85.02.100 provides that the Docks and Harbors Board shall annually, or more often as the need may arise, approve a schedule of fees and charges for use of the ports and harbors and their facilities, thereby rendering Resolution 1753 and portions of Resolution 1754 obsolete, and

WHEREAS, the Docks and Harbors Board at its meeting of March 28, pursuant to CBJ 85.02.100 approved a schedule of fees, rates, and charges for the use of the city and borough port facilities and small boat harbors, and

WHEREAS, CBJ 85.02.105 provides that the Docks and Harbors Board may change the port dues base rate provided that the change does not become effective until confirmed by resolution by the Assembly, and

Whereas, the Docks & Harbors Board at its meeting of February 1, 1996, proposed that the port dues be established at a base rate of 21 cents per registered net ton, and

Whereas, the Assembly Finance Committee at its meeting of March 20, 1996, reviewed the Board's proposal and recommended to the Assembly that the port dues be established at a base rate of 20 cents per registered net ton;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

**Section 1. City and Borough Port Dues.** The port dues for use of the city and borough port facilities shall be as follows:

(a) Port Dues. Vessels carrying passengers for compensation and utilizing the port facilities and not specifically exempted under CBJ 85.02.105(d) shall be assessed and pay port dues of \$0.20 per net registered ton for each port visit, the establishment of such dues by resolution being authorized as provided in CBJ 85.02.105(c).

**Section 2. Repeal of Resolutions.** Resolutions 1753 and 1754 are hereby repealed.

**Section 3. Effective Date.** This resolution shall be effective immediately upon adoption.
