**RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA**

**A Resolution Correcting Errors in the Assessment Roll for Local Improvement District No. 72 Previously Confirmed by the Assembly by Resolution No. 1813.**

WHEREAS, the Assembly of the City and Borough of Juneau by Ordinance Serial No. 92-34, adopted September 14, 1992, created LID No. 72 for the purpose of providing improvements consisting of construction and installation of an interceptor and collector sewer system on portions of Glacier Avenue, Norway Point, Glacier Highway, Bartlett Avenue, Dimond Drive, Wickersham Avenue, Sutherland Drive, Channel Vista Drive, Channel Drive, and Egan Drive, and

WHEREAS, the Assembly of the City and Borough of Juneau by Resolution Serial No. 1813, adopted May 20, 1996, confirmed the special assessment roll for LID No. 72, and
