RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A Resolution Accepting the Fiscal Year 1998 Municipal Capital Matching Grants.

WHEREAS, the State of Alaska has established the Municipal Capital Project Matching Grant Program under AS 37.06, and

WHEREAS, the State of Alaska Department of Administration has made available under this program nine grant projects for a total of \$769,955, and

WHEREAS, the City and Borough of Juneau has agreed to contribute a total of \$407,100 as its share of these projects;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:
