## **RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA**

**Serial No. 1923**

### **A Resolution Establishing the 1998 Port Dues for the City and Borough of Juneau Port Facilities, and Repealing Resolutions 1753 and 1754.**

WHEREAS, the Assembly by Resolution 1812 adopted pursuant to CBJ 85.02.105 established the 1996 port dues for the city and borough, and

WHEREAS, said dues remained unchanged for 1997, and

WHEREAS, CBJ 85.02.105 provides that the Docks and Harbors Board may change the port dues base rate provided that the change does not become effective until confirmed by resolution by the Assembly, and

WHEREAS, the Docks & Harbors Board at its meeting of February 26, 1998, proposed that the port dues be established at a base rate of 21 cents per registered net ton, and

WHEREAS, the Assembly Finance Committee at its meeting of March 18, 1998, reviewed the Board's proposal and recommended to the Assembly that the port dues be established at a base rate of 21 cents per registered net ton, and

WHEREAS, Resolution Nos. 1753 and 1754, adopted in 1995 pursuant to CBJ 05.02.100, established fees and charges for the small boat harbors and port facilities respectively, are no longer necessary, inasmuch as CBJ 05.02.100 was amended by Ordinance 95-05 to grant the Docks & Harbors Board to establish such fees and charges without Assembly action, which authority the Board exercised at its meeting of April 30;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:


**Section 1. City and Borough Port Dues.** The port dues for use of the city and borough port facilities shall be as follows:

(a) Port Dues. Vessels carrying passengers for compensation and utilizing the port facilities and not specifically exempted under CBJ 85.02.105(d) shall be assessed and pay port dues of \$0.21 per net registered ton for each port visit, the establishment of such dues by resolution being authorized as provided in CBJ 85.02.105(c).

**Section 2. Repeal of Resolutions.** Resolution Nos. 1753 and 1754 are repealed.

**Section 3. Effective Date.** Section 1 of this resolution shall be effective immediately upon adoption, Section 2 shall be effective on June 30, 1998.
