RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION ESTABLISHING RATES FOR  
 THE AUGUSTUS BROWN SWIMMING POOL.

WHEREAS, it is necessary to adjust the fees for use of the Augustus Brown Swimming Pool to keep pace with increased costs of operation,

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That for other than public school uses, the following swimming pool rates and conditions are established:

A. Admission Fees

90-minute swim	\$ 3.00	\$ 1.00	Free
60-minute swim	2.50	.75	Free
Penny swim	.75	.75	Free

B. Pool Rentals

<u>Number of persons in group</u>	<u>Hourly Rate</u>
1 - 50	\$ 40.00
51 - 100	45.00
101 - 150	50.00
151 - 200	55.00

Minimum pool rental fees shall be the fee for one hour at the applicable rate. After the first hour, the fee may be incremented on a quarter hour basis, each quarter hour or part thereof being charged as one-fourth the applicable hourly rate.

C. Lessons

45-minute lesson	2.50	1.25
30-minute lesson	2.00	1.00



Water safety classes on drown proofing, cold water survival, use of flotation devices and similar classes may be offered at a rate which is estimated will provide recovery of direct personnel and materials costs.

D. Monthly Tickets

Tickets good for one calendar month or any part of a calendar month shall be available at the following rates:

Monthly tickets are non-transferable and no refunds for any reason may be made. The manager or his designee may prorate the monthly fee for any month during which there is a planned closure of the swimming pool.

E. Youth Swim Team Rate

The monthly rate for youth swim team use, but not exceeding 50 hours per month including all uses, will be \$700 per month for FY 83-84 and \$800 per month for FY 84-85. If the swim team uses the pool for 14 days or less during a month and for 25 hours or less during the 14 day period, the pool manager may reduce the fee by one-half for that month. Use in excess of 50 hours per month will be charged at a fixed rate of \$7.50 per hour. The city and borough will provide a coach for the team not to exceed 18.7 hours per week for 11 months.

F. Showers

The rate for showers taken by persons who have not paid a regular admission for swimming pool use shall be \$1.50.



G. Exemptions for Handicapped Persons

Admission fees may be waived during periods scheduled by the pool manager for persons participating in programs conducted by non-profit organizations or the city and borough where such programs are for handicapped persons.

H. Refunds and Complimentary Tickets

Refunds may not be made.

Whenever the swimming pool is closed during the first half of a scheduled public swim, each patron who has paid an admission for that swim shall be entitled to a complimentary ticket which may be used as admission to a subsequent swim costing the same for admission as the swim that was interrupted. Complimentary tickets are not available for those who gained admission through a monthly or other pass type of ticket. If the pool is not available for group use for at least one-half the period of time for which the pool is rented to a group under paragraph B, the group shall be entitled to use the pool for the full period of the rental at another time determined by the pool manager.

I. Definitions

"Adult" means a person who is 18 years of age or older.

"Family" means spouses, parents and children (including foster children under a state program) living as a family unit in the same residential unit.

"Infant" means a person under 2 years of age who is accompanied by an adult.

"Senior Citizen" means a person who is 65 years of age or over.

"Youth" means a person who is less than 18 years of age.

2. That Resolution Serial Nos. 217, 464, 580, 757, 792, 838, 867, 902 and all other resolutions inconsistent herewith are repealed.



3. That this resolution shall be effective on July 1, 1983.
