RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 1265

A RESOLUTION AUTHORIZING THE MANAGER TO TRANSFER A SURPLUS
AMBULANCE TO THE SOUTHEAST REGION EMERGENCY MEDICAL COUNCIL.

WHEREAS, Section 53.50.220 of the city and borough code requires Assembly approval by resolution prior to a transfer to another governmental or quasi-governmental unit of any surplus city and borough supplies with an estimated value of greater than two hundred dollars, and

WHEREAS, the city and borough has a 1978 E350 Type 3 Modular Ambulance that is surplus to the needs of the city and borough, and

WHEREAS, the Southeast Region Emergency Medical Council (the "Council"), is a quasi-governmental unit funded by the State of Alaska, Department of Public Safety, which, among other functions, identifies needs and establishes priorities for emergency medical services for the communities in Southeast Alaska, and

WHEREAS, the Council has identified several communities in Southeast Alaska that are in need of an ambulance unit of this type, and

WHEREAS, with certain repairs, the surplus ambulance would serve the limited needs of such communities, and

WHEREAS, it has been determined that the estimated maximum value of the surplus ambulance is \$2,000, and

WHEREAS, it is the policy of the city and borough to assist its sister communities in Southeast Alaska when possible, and

WHEREAS, it has been determined that the best interests of the public would be served by this transfer of supplies to the Council for purposes of further transfer, without profit, to another governmental unit in Southeast Alaska;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That the manager is authorized to transfer the 1978 E350 Type 3 Modular Ambulance to the Southeast Region Emergency Medical Council for the purpose of transfer by the Council, without profit, to the community in Southeast Alaska with the greatest need for the unit as determined by the Council in accordance with its standard procedures for identifying needs and establishing priorities for emergency medical services for the communities in Southeast Alaska.

2. That the city and borough shall not be responsible for any costs or expenses associated with the transfer of the 1978 E350 Type 3 Modular Ambulance to the Council or to the community chosen by the Council, including but not limited to any and all costs and expenses associated with repairing, reconditioning, and shipping the unit.

3. Effective Date. This resolution shall be effective immediately upon adoption.
