RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION AMENDING RESOLUTION NO. 674 TO  
ESTABLISH CONNECTION AND USER FEES FOR  
SIX INCH CONNECTIONS.

WHEREAS, Resolution Serial No. 674 does not provide connection or user fees for water utility customers using a six inch connection, and

WHEREAS, the city and borough will be providing six inch connections,

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That section 2B(1) of Resolution Serial No. 674 is amended to read:

2B(1) The following minimum charges will be made for each water service connection:

<u>Connection Size in Inches</u>	<u>Charge</u>
3/4	\$ 117.25
1	132.75
1 & 1/2	164.00
2	197.75
3	257.75
4	320.25
6	750.00

Provided, however, that if the labor, materials, and equipment usage exceeds the charge set forth herein, the charge shall be the cost of the labor, materials, and equipment usage, plus ten percent (10%) for administration and inspection costs. In any case where the providing of such service necessitates the breaking of street paving or a sidewalk, there shall be an additional charge for such breaking based on the labor, materials, and equipment usage involved in breaking and restoring such paving, plus ten percent (10%) for administration and inspection costs.

2. That section 2E(1)(a) of Resolution Serial No. 674 is amended to read:

2E(1)(a) Minimum monthly charges for the first 4,000 gallons:

<u>Water Connection Size in Inches</u>	<u>Charges Per Month</u>
3/4	\$ 9.96
1	19.93
1 & 1/2	46.88
2	82.04
3	181.64
4	328.13
6	740.00

3. That section 2E(2)(a) of Resolution Serial No. 674 is amended to read:

2E(2)(a) Monthly charges shall be:

3/4	\$ 14.06 + 5.86 each additional unit
1	29.30 + 5.86 each additional unit
1 & 1/2	64.45 + 5.86 each additional unit
2	117.19 + 5.86 each additional unit
3	263.68 + 5.86 each additional unit
4	468.75 + 5.86 each additional unit
6	1,050.00 + 6.00 each additional unit
