RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION AMENDING RESOLUTION SERIAL NO. 665
TO ESTABLISH NEW RATES FOR USE OF FACILITIES
AT THE EAGLECREST SKI AREA.

WHEREAS, the assembly, by Resolution Serial No. 665, established a new rate structure for the use of facilities at Eaglecrest, and

WHEREAS, the increased cost of labor and materials requires an increase in such rates;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That Resolution Serial No. 665 is amended by changing paragraph 1(a) to read as follows:

(a). Lift Tickets

2. That Resolution Serial No. 665 is amended by changing paragraph 2 to read:

2. Lessons.

(a) Group Lessons

Learn to ski special for first-time beginners (includes two two-hour lessons and a surface lift ticket) \$ 14.00

Regular group lessons (4 hours) 13.00

Regular group lessons (2 hours) 10.00

Cross country group lesson (2 hours) 10.00

(b) Private Lessons

One hour (one student) \$ 17.00

One hour (each additional student) 5.00

Private lessons are limited to a maximum of four (4 students).

(c) Lesson Refunds. A cash refund will be granted for prepaid lessons for reasons of illness or injury if notification of such is received prior to the first lesson.

3. That Resolution Serial No. 665 is amended by changing paragraph 3 to read:

3. Day Lodge Rental.

(a) Rental rates:

First hour of use (minimum charge) \$ 100.00

Each additional hour 20.00

Maximum charge per day 200.00

(b) Deposits:

Damage and theft deposit (refundable if no damage or theft occurs) \$ 100.00

Cleaning deposit (refundable if lodge is adequately cleaned after use and before next scheduled use) 30.00

4. That paragraph 4 of Resolution Serial No. 665 is amended to read:

4. Lockers.

Seasonal rental of a locker (under such terms, conditions, and priorities as the manager may establish) \$35.00

5. That for the 1981-82 season, persons or families purchasing a season ticket on or before November 15, 1981, shall be allowed an additional ten percent (10%) discount if the person or family held a season ticket for the 1980-81 season.

6. That this resolution shall become effective on July 1, 1981.
