RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION ESTABLISHING THE RATE OF LEVY FOR PROPERTY TAXES FOR THE FISCAL YEAR BEGINNING JULY 1, 1982

WHEREAS, AS 29.53.170, which is applicable to home rule municipalities, provides that the rate of the levy of the general property tax is to be fixed by resolution, and

WHEREAS, the assembly has considered and approved the operating and capital budget for the fiscal year beginning July 1, 1982, and

WHEREAS, the expressed legislative intent was only that increased funding under the Municipal Assistance appropriation be used for the reduction of real property taxes, and

WHEREAS, the assembly has determined to use both its state Municipal Assistance and state Revenue Sharing entitlement for FY 1983 for tax reduction, and

WHEREAS, the assembly has distributed said entitlements among the service areas and the areawide functions, and

WHEREAS, the distribution resulted in a reduction of the required areawide millage from 15.07 mills to 6.04 mills, and

WHEREAS, the combined areawide and service area millage rates required in each service area both with and without the use of the entitlements for tax reduction are as set forth in the following table:

1. That the following are the rates of levy on taxable property within the City and Borough of Juneau for the fiscal year beginning July 1, 1982, based upon the approved budget for that year and the certified assessment roll:
