**Situation Assessment:** Our 14 day and 7 day case rate indicators are at the moderate alert level - primarily due to secondary transmission. The community continues to see COVID transmit via community spread, secondary infection, and travel. The more aggressive variants of COVID-19 have been identified in Alaska. We caution the public to strictly adhere to all travel related rules and to continue strict adherence to masking and social distancing when outside your immediate home.

**Issues of Note:**

30.2% of the Juneau population age 16 and above have been vaccinated with 20.6% of the population having received their 2<sup>nd</sup> dose. The State is reporting that 78.7% of the population in Juneau age 65+ have received at least the first dose of vaccine.

POD 2b is scheduled for Thursday, March 4 and Friday, March 5. This is the second dose clinic for the 2a clinic which occurred on February 11<sup>th</sup> and 12<sup>th</sup>.

Registration for POD 3a (Friday March 12, noon to 7pm and Saturday March 13, 9am to 4pm) is open. 490 appointments remain. Registration will remain open until slots are filled. POD 3b (second dose clinic) is scheduled for April 2 and 3.

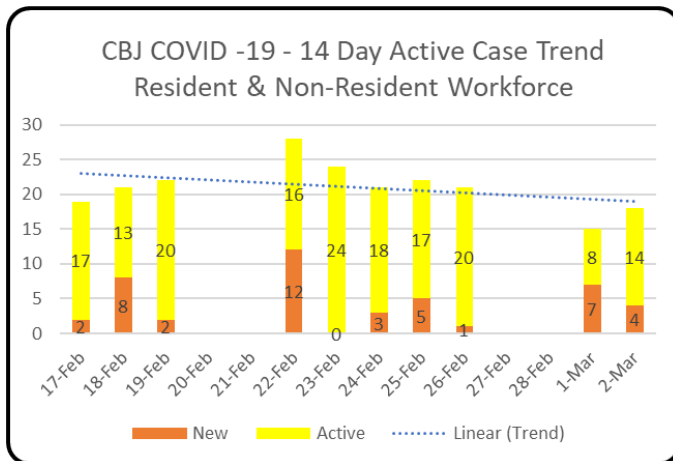
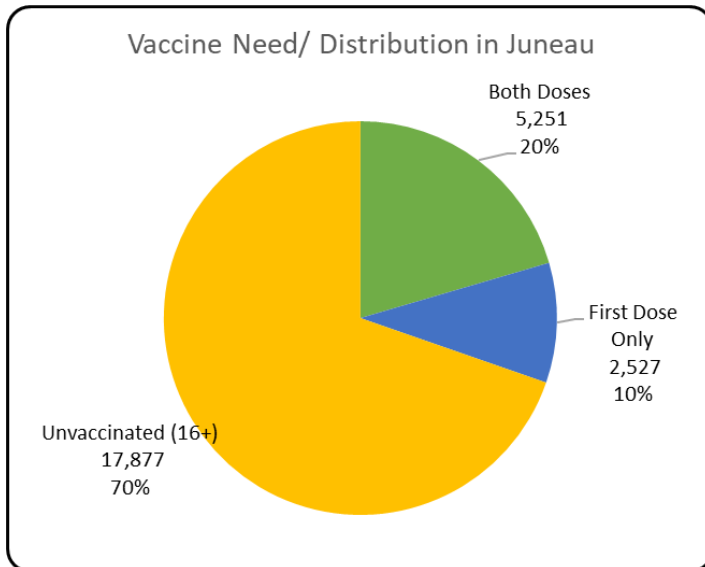

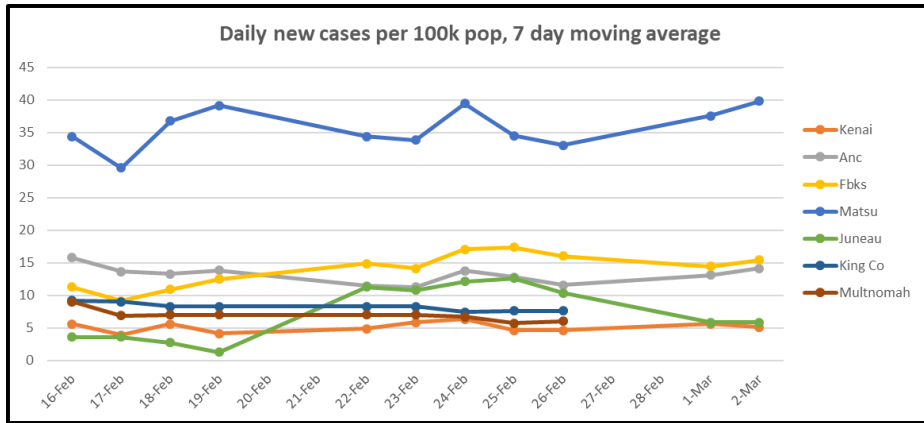
Disease Transmission/Contact Tracing:

We are reporting 4 new resident cases and no new nonresident cases today. 3 cases are secondary transmission and 1 is under investigation.

The State is reporting 159 new cases today bringing the statewide cumulative total to 58,837 cases.

Testing: 3/01/21: 43 test results were received from the Fulgent Lab with collection dates between 02/26/2021 – 02/28/2021 – 14 tests returned in 1 day, 27 tests returned in 2 days, and 2 tests returned in 3 days.





This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (<https://globalepidemics.org/key-metrics-for-covid-suppression/>) and generally lags a day behind most of our other reporting.
