Request for Modification Waiver for Off-Highway Vehicle Training Workshop

The Parks and Recreation Department seeks to hire a non-profit, National Off-Highway Vehicle Conservation Council (NOHVCC), to host a staff and volunteer workshop in Juneau on designing and constructing OHV trails at 35 mile. NOHVCC is the only organization in the US that travels to and works with communities around the country on OHV design and construction.

In 2013, as a subcontractor to a local engineering firm, NOHVCC came to Juneau to work with CBJ and produced a feasibility report for the 35 mile ORV park. As part of this work, they did field assessment of the site, gathered GIS and topo data, environmental data, and led a public meeting and stakeholder meetings. The report they produced is attached and they also produced slideshows for their public meetings.

This organization is known throughout the country as the industry voice for safety and stewardship of OHV construction, maintenance, management, and training. Their stated mission and objectives from their website (https://nohvcc.org/about-us/) is:

Mission

NOHVCC, as a national body of OHV recreation enthusiasts, develops and provides a wide spectrum of programs, materials and information, or "tools", to individuals, clubs, associations and agencies to further a positive future for responsible OHV recreation.

Mission Objectives

- Help establish new OHV clubs and state associations where they don't already exist;
- Strengthen existing clubs and state associations by providing information, training and services to help them be more effective;
- Improve and promote responsible OHV recreation management and resource protection by working in partnership with private and public land managers and recreation planners;
- Provide and promote best management practices for OHV recreation planning, development and management to policy makers;
- Promote a positive OHV recreation image to all publics;
- Build a better understanding of responsible OHV recreation among all publics;
- Build recognition and acceptance that OHV recreation is a positive activity and promotes a responsible life style;
- Provide broad-based, ongoing educational opportunities for OHV recreationists, recreation
 planners and decision-makers; Provide and promote educational, safety, ethics,
 environmental and character-building programs for all OHV recreationists including youth;
 and
- Emphasize the benefits of responsible recreation behavior and raise awareness of the impacts from irresponsible recreation activity.

In researching other riding parks and state and municipal riding areas, NOHVCC's work, training, management plans are found across the country. I cannot find anyone else that does this type of work. This work may be funded by the Alaska DNR Recreation Trails Program. P&R applied for this grant and included this project in the request. We should find out if they grant is awarded in February or March 2023. If not, we will fund this work through existing CIP funding.
