My Parking Receipt™



Users may also set up a profile to review their expense history and receive automatic emailed receipts when they pay with a card linked to their account.

This user experience enhancement allows flexibility for customers to manage their parking expenses for record-keeping and reporting purposes. My Parking Receipt is available to all IPS customers *at no additional cost* and managed through the powerful IPS DMS.

Customers simply go to MyParkingReceipt.com to look up transactions from the last six months using their credit card information and the transaction date range. Users may also create an account so that whenever the credit card linked to the account is used, the receipt is automatically emailed to them.



Any current internet browser will be sufficient to access the EMS. MS Explorer, Mozilla Firefox, Google Chrome, iOS-supported browsers are all compatible, including mobile phone browsers.






