CBJ also requests the Court add a date to the Order that was included in the parties' Joint Status Report Regarding Scheduling and Planning Order Dates [Docket 57]. Counsel for Plaintiff has authorized the undersigned to advise the Court the motion is not opposed.

The parties submitted a Joint Status Report Regarding Scheduling and Planning Order Dates [Docket 57]. The parties requested that preliminary motions be due on October 20, 2017 and that dispositive motions be due on May 15, 2018. The Second Amended Scheduling and Planning Order adopted all the proposed dates from the parties, except these two dates. The Order is silent on the preliminary motions due date, and has March 30, 2018 as the due date for dispositive motions.

CBJ respectfully requests the Court enter a due date for preliminary motions, and requests that date be October 20, 2017 as agreed upon the parties in the Joint Status Report.

CBJ also respectfully requests the Court change the dispositive motion date to May 15, 2018, as agreed upon and proposed by the parties. Counsel for the CBJ (both Robert P. Blasco and Megan J. Costello) will be in Utqiagvik (Barrow) from March 22, 2018 until April 16, 2018 for trial. (*Tomas v Arctic Slope Regional Corporation*, 2BA-14-63CI). The case has been continued three times, including for not being able to seat a jury due to lack of jurors. The case is now set for a time where there will be two jury pools available for jury selection. There is no settlement possibility. The CBJ will be without responsive counsel during March 22, 2018 until April 16, 2018 as Mr. Blasco and Ms. Costello are the only counsel at Hoffman & Blasco committed to the defense of CBJ in this case. Due to this significant scheduling commitment conflict of counsel for CBJ, counsel for CLIA graciously agreed to the May 18, 2018 dispositive motion date.
