AMENDED SECOND AMENDED SCHEDULING AND PLANNING ORDER

Based upon the parties' joint status report and proposal regarding scheduling and planning order dates,¹ filed June 13, 2017, the court's amended scheduling and planning order² of January 25, 2017, was further amended by the court's second amended scheduling and planning order.³

By unopposed motion, defendants seek a further revision of the case schedule in two respects: (a) the parties had asked for a date for the filing of preliminary motions, and (2) the parties had requested that dispositive motions be due May 15, 2018. With

plaintiffs' concurrence, defendants seek to have the court include both of their foregoing requests.

The court omitted a date for the filing of preliminary motions purposefully. This case was commenced by the filing of plaintiffs' original complaint on April 13, 2016.⁴ Initial motion practice was undertaken and has been resolved.⁵ The court ordinarily calls for preliminary motion practice within 60 days of the filing of a complaint for purposes of taking up such matters as jurisdiction and venue, etc. It is the court's perception that the time for "preliminary" motions has passed; but the parties should understand that the absence of that provision does not preclude any party from filing a timely motion on any subject.

With respect to the time for dispositive motions, defendants have shown good cause for the court to defer the deadline for filing dispositive motions from March 30 to May15, 2018.

The second amended scheduling order is further amended as follows:
