The undersigned discussed this sequence of events with counsel for Plaintiffs on February 6, 2018, and CBJ's proposed modifications. The undersigned requested Plaintiffs' counsel to stipulate to those modifications. Plaintiffs' counsel agreed to do so with CBJ's acknowledgment that the requested changes in this Stipulation are solely proposed by CBJ.

With the above explanation, the parties agree and stipulate and request the Court order that the Order at Docket 114 be modified as follows:

1. CBJ requests three days to file their Cross-Motion and Opposition, Statement of Facts, and Objections to CLIA's Statement of Facts, and corresponding affidavits and exhibits and related Motion to Take Judicial Notice. This filing would be due on February 9, 2018.
2. The Plaintiffs' Opposition to CBJ's Cross-Motion and Reply in Support of the Plaintiffs' Summary Judgment Motion would be due on March 2, 2018.
3. CBJ's Reply in Support of CBJ's Cross-Motion would be due on March 16, 2018.
4. CBJ's Reply may be up to 50 pages in length.

This Stipulation will not cause any undue delay.
