**JOINT STIPULATION REGARDING DEADLINES FOR PAPERS
RELATED TO MOTION FOR SUMMARY JUDGMENT (ECF NO. 67) AND CROSS-
MOTION FOR SUMMARY JUDGMENT (ECF NO. 118)**

- 5) Opposition to Defendants' Motion to Strike Certain Exhibits (ECF No. 99);
- 6) Opposition or other necessary response to Defendant's Sealed Motion Requesting Leave to File Documents and Pleadings Under Seal (ECF No. 105);
- 7) Opposition or other necessary response to Defendant's Motion Requesting Leave to File Exhibit HY Conventionally (ECF No. 138); and
- 8) Any additional motions or papers necessary to address Defendants' supporting documents, including the various affidavits filed by Defendants (ECF Nos. 131, 132, 133, and 136).
