- 5. Reply in Support of Plaintiffs' Motion to Strike Affidavit of Bruce Botelho (ECF No. 151; ECF No. 165);
- 6. Reply in Support of Plaintiffs' Motion to Strike Affidavit of Bob Bartholomew (ECF No. 150; ECF No. 167); and
- 7. Any additional motions or papers necessary to address Defendants' May 1 filings.

To the extent that Defendants need to reply in support of their Motion to Take Judicial Notice (ECF No. 173), Defendants shall file such reply on or before June 1, 2018. Further, should Plaintiffs file any other motion(s), or other filings, Defendants shall file their opposition(s) to such motion(s) or response(s) to other filings on or before June 8, 2018, and Plaintiffs shall file their reply(ies) in support of such motion(s) on or before June 20, 2018.
