Eaglecrest

Mr. Gary Cuzia read a letter from Paul Swanson.

Mr. Eric Stewart, JEDC Business Counselor, made a statement indicating that Eaglecrest is a community recreational facility and as such should not be expected to be able to generate sufficient revenues to full fund its operations. Mr. Stewart has stated the significance of Eaglecrest to the community and its economic viability.

Mr. Gary Mendivil, Eaglecrest Business Manager, Gary Hogins, Eaglecrest Board President, Jeff Morehouse, Eaglecrest Finance Chair, and Jeffra Clough, Eaglecrest Marketing gave the presentation. Other staff and board members were also present.

Eaglecrest has requested an additional \$100,000 in general governmental support. This has been added to the Pending Items List.

Marine Passenger Fee

Rod Swope presented changes from his original recommendations of March 4, 2004 (see memo dated May 26, 2004).

Randy Wanamaker spoke in favor of including \$300,000 for Shoreside Power.

Mr. Tom Dow, Carnival Corporation, requested the continuation of the \$300,000 payment for the Shoreside Power project.

Mr. Chip Toma presented information from the NW Cruise Association indicating cruise ship smoke emissions is a non-issue.
