Good morning everyone -

It appears that Tuesday, October 29th at 11:00 am is a time available to everyone to discuss water and wastewater issues.

I have asked to have room 224 in City Hall reserved for the meeting

Kirby and Drew – I would appreciate you thinking about the needs of the cruise ships when it comes to supplying water and being able to process wastewater for the upcoming 10 years. I understand that it is difficult to read the crystal ball. That being said, CBJ Public Water is planning for the future and we need to start somewhere when it comes to satisfying the needs to the cruise industry.

I believe that currently the goal is to have 500,000 gallons of water available each day for the cruise ships during the cruise ship season. We are only meeting 50% of that request at this time.

I am uncertain how best to plan for the wastewater needs. Currently we process about 66,000 gallons of wastewater each day coming from the Princess ships. The strength of the gray water varies from normal strength to over 11 times normal strength which makes planning for future needs very interesting.

Any information or thoughts you could provide concerning the future needs of the cruise ships would be very helpful.

Please let me know if the timing of the meeting does not work for you.
