

Definitions:

Revenue Passenger: means any person who has paid any amount for a ticket contract entitling that person to transportation aboard ship. The term does not include (1) the owner's or operator's employees or their immediate family members sharing their quarters; (2) the owner's or operator's contractors or subcontractors; or (3) musicians, artists, guest speakers, art auctioneers, interpreters, rangers, or similar persons traveling without charge and providing passenger services for the ship's owner or operator.

Visit: means an entry into a port or dock within the boundaries of the City more than twenty-four (24) hours before or after another entry by the same ship, excluding visits for emergency purposes.
