Each of these exhibits, which are attached to Plaintiffs' Statement of Facts, may be judicially noticed by this Court and may be referenced and relied upon by the Court as it

considers Plaintiffs' request for judgment in their favor on the claims asserted in Plaintiffs' *First Amended Complaint* (ECF No. 28).

II. Legal Authority for Taking Judicial Notice of this Material

Federal Rule of Evidence 201 allows a court to take judicial notice of facts that are "generally known within the territorial jurisdiction of the trial court " or can be "accurately and readily determined from sources whose accuracy cannot reasonably be questioned." FED. R. EVID. 201(b); *Hansen v. City of San Francisco*, No. 12-CV-04210-JST, 2014 WL 1310282, at *2 (N.D. Cal. Mar. 31, 2014) (a "court shall take judicial notice of a fact "not subject to reasonable dispute in that it is capable of accurate and ready determination by resort to sources whose accuracy cannot reasonably be questioned"). Pursuant to the Rule, the court "must take judicial notice if a party requests it and the court is supplied with the necessary information." FED. R. EVID. 201(c)(2). This motion is filed pursuant to Local Rule 7.1(d) which provides that when a "citation or reference is made to materials or information not readily available to the public in printed form, or to an internet site, the citing party must attach a copy as an exhibit to the motion ... [and] file a separate motion that the court take judicial notice of the materials or information cited under Federal Rules of Evidence, Rule 201."

A. <u>Statutes, Ordinances, Resolutions, and Code Provisions</u>

State statutes, city charters, and city and municipal ordinances are proper subjects of judicial notice. *See Hansen*, 2014 WL 1310282, at *2 (citing *Newcomb v. Brennan*, 558 F.2d 825, 829 (7th Cir. 1977) ("[C]ity ordinances fall within the category of 'common knowledge' and are therefore proper subjects for judicial notice.")); *Engine Mfrs. Ass'n v. S. Coast Air Quality Mgmt. Dist.*, 498 F.3d 1031, 1039 (9th Cir. 2007) (municipal ordinances are proper subjects for judicial notice); *Santa Monica Food Not Bombs v. City of Santa Monica*, 450 F.3d

1022, 1025 (9th Cir. 2006) (taking judicial notice of municipal ordinances); *Lee v. City of Los Angeles*, 250 F.3d 668, 689 (9th Cir. 2001) (noting that judicial notice may be taken of public records); *see also Cuviello v. City of Vallejo*, No. 216CV2584KJMKJNPS, 2017 WL 1534277, at *2 (E.D. Cal. Apr. 28, 2017), *report and recommendation adopted*, No. 216CV2584KJMKJNPS, 2017 WL 3840256 (E.D. Cal. Sept. 1, 2017) (granting request for judicial notice of municipal code chapters).

Exhibits 5 through 13 and 15 are ordinances, resolutions, and codes adopted by CBJ, an Alaska municipality, and therefore are public records and a proper subject of judicial notice. Moreover, this Court has already taken judicial notice of two such exhibits that were previously offered in support of Plaintiffs' Opposition to Defendants' Motion to Dismiss (ECF No. 34), and that are now being offered in support of Plaintiffs' Motion (*see* Exhibits 10 and 11).

Exhibits 17 through 20 are Alaska state statutes adopted by the Alaska legislature. These Exhibits are proper subjects for judicial notice (to the extent such judicial notice is necessary) because Alaska statutory provisions fall within the "common knowledge" of this Court and are public records.

B. CBJ Documents Available Publicly Online

Similarly, courts routinely take judicial notice of documents and information made publicly available online by government entities. *Daniels-Hall v. Nat'l Educ. Ass'n*, 629 F.3d 992, 998–99 (9th Cir. 2010) (taking judicial notice of list of approved vendors displayed publicly on school district websites) (citing, among others, *In re Amgen Inc. Sec. Litig.*, 544 F. Supp. 2d 1009, 1023–24 (C.D. Cal. 2008) (taking judicial notice of drug labels taken from the FDA's website); *Cty. of Santa Clara v. Astra USA, Inc.*, 401 F. Supp. 2d 1022, 1024 (N.D. Cal. 2005) (taking judicial notice of information posted on a Department of Health and Human Services

web site)); *Gerritsen v. Warner Bros. Entm't Inc.*, 112 F. Supp. 3d 1011, 1033–34 (C.D. Cal. 2015) ("Under Rule 201, the court can take judicial notice of "[p]ublic records and government documents available from reliable sources on the Internet," such as websites run by governmental agencies") (citing, among others, *Paralyzed Veterans of Am. v. McPherson*, No. C 06–4670, 2008 WL 4183981, at *5 (N.D. Cal. Sept. 8, 2008) ("Information on government agency websites has often been treated as properly subject to judicial notice")).

Here, Exhibits 73, 74, 77 through 99, 106, 107, 109 through 112, 114, 115, 117 through 119, and 121 through 133 are properly subject to judicial notice by this Court, as they are CBJ documents available publicly online or information that CBJ has made available online. For example, Exhibit 78 and Exhibits 124 through 133 are excerpts from CBJ's own Biennial Budget documents for FY 2008 through FY 2016, and Exhibits 79 through 97 are excerpts from CBJ's own Consolidated Annual Financial Reports. CBJ created these documents and made them publicly available. CBJ cannot dispute their accuracy, particularly for the limited purposes relied upon by Plaintiffs. Moreover, this Court has already taken judicial notice of one such exhibit (*see* Order at ECF No. 34) that is again being offered in support of Plaintiffs' Motion (*see* Exhibit 96). All of these documents and information contained in the Exhibits referenced in this paragraph came from one or more websites run by CBJ or one of its departments. Therefore, these materials are proper subjects of judicial notice.

Exhibits 100, 108, and 116 are documents and information made available publicly by the State of Alaska, on websites run by the State of Alaska. Therefore, these materials are proper subjects of judicial notice.

Exhibit 76 is the Approved Jurisdictional Determination Form for the Gastineau Channel, available publicly online courtesy of the U.S. Army Corps of Engineers, a government agency. Therefore, the jurisdictional form is a proper subject of judicial notice.

C. <u>Documents Availably Publicly Online From Reliable Sources</u>

Finally, in "this new technological age[,]" courts may take judicial notice of documents "insofar as they are available via the worldwide web" when the Court is supplied with the necessary information to access the website and confirm the accuracy of the document's content. *In re Tourism Assessment Fee Litig.*, No. 08CV1796-MMA WMC, 2009 WL 10185458, at *4–5 (S.D. Cal. Feb. 19, 2009) (quoting *In re Agribiotech Sec. Litig.*, 2000 U.S. Dist. LEXIS 5643, *4–5 (D. Nev. Mar. 2, 2000)), *aff'd*, 391 F. App'x 643 (9th Cir. 2010); *see also Barnes v. Marriott Hotel Servs., Inc.*, No. 15-cv-01409-HRL, 2017 WL 635474, at *4 (N.D. Cal. Feb. 16, 2017) ("It is not uncommon for courts to take judicial notice of factual information found on the world wide web.") (citations omitted).

Exhibits 71, 72, 75, 101 through 105, 113, 120, and 134 are properly subject to judicial notice by this Court, as they are documents available publicly online. Plaintiffs have provided the Court with website addresses (in hyperlinks) for each of these documents in this Motion and in Plaintiffs' Index of Exhibits, enabling the Court to access the websites and confirm the accuracy of the documents' content. Also, some of the materials are proper subjects of judicial notice apart from their public availability on the internet. *See In re Am. Apparel, Inc. S'holder Derivative Litig.*, No. CV 10-06576 MMM RCX, 2012 WL 9506072, at *19 (C.D. Cal. July 31, 2012) (taking judicial notice of the contents of press releases and new articles). Therefore, these materials are proper subjects of judicial notice.

III. Conclusion

For the reasons outlined above, Plaintiffs respectfully move the Court to take judicial notice of Exhibits 5 through 13, 15, 17 through 20, and 72 through 134 to Plaintiffs' concurrently filed Motion for Summary Judgment and Statement of Facts in Support of Motion for Summary Judgment.
