1. My name is Lalanya Downs. I am Director, Public Affairs and Administration at

Cruise Lines International Association (CLIA). Prior to the transfer of assets of CLIA Alaska to

CLIA, I was Public Affairs Specialist and then Director, Public Affairs and Administration at CLIA Alaska, previously Alaska Cruise Association, for over ten years.

2. I am over the age of twenty-one and, if called upon as a witness, I could and would testify competently under oath as to the contents of this Declaration.

3. I make this Declaration on personal knowledge and information available to me in my role as Director, Public Affairs and Administration at CLIA.

4. I understand that CBJ refers to a entity named Northwest Cruise Association (NWCA) in its summary judgment papers. To the best of my knowledge, CBJ is referring to an entity that began as a Canadian association under the name Vancouver Cruise Ship Terminal Users Association. It was renamed North West Cruise Ship Association in the late 1980s. In June 2010, North West Cruise Ship Association changed its name to North West & Canada Cruise Association. In 2013, North West & Canada Cruise Association became Cruise Lines International Association – North West & Canada (CLIA-NWC).

 CLIA-NWC is affiliated with CLIA. CLIA is not the parent company of CLIA-NWC.

6. Alaska Cruise Association was formed on February 7, 2007 as an Alaska nonprofit corporation. In 2013, Alaska Cruise Association changed its name to CLIA Alaska. CLIA Alaska was not a subsidiary of CLIA. CLIA Alaska was affiliated with CLIA. CLIA was not the parent company of CLIA Alaska.

7. CLIA is a District of Columbia nonprofit corporation.

8. In November 2016, CLIA Alaska voted to voluntarily dissolve and transfer substantially all of its assets to CLIA.

9. On December 8, 2016, CLIA Alaska executed documents necessary for voluntary dissolution under Alaska state law. *See* Exhibits A and B hereto, which are true and correct copies of CLIA Alaska's Resolution to Dissolve and Articles of Dissolution.

10. On January 5, 2017, CLIA registered as a foreign nonprofit corporation with the State of Alaska. *See* Exhibit C hereto, which is a true and correct copy of the confirmation document for CLIA's filing as a foreign nonprofit corporation in Alaska.


