Port Director's Corner:

September may mark the end of the boating and cruise ship season for some – but for Docks & Harbors it starts the clock of what will surely be another extremely busy "off season". On September 15th, the public will observe all vessels on A thru D Floats in Aurora Harbor have been relocated to Statter, Douglas, Harris Harbors and the Intermediate Vessel Float. This will provide Docks & Harbors an opportunity to salvage useable hardware and electrical pedestals before the general contractor (Northern Construction Service) and their sub-contractor (Trucano Construction) begin the demolition in early October. Docks & Harbors schedulers Dolly Raster and Dennis Holloway have been coordinating the relocation of over 110 vessel in an admirable fashion. Juggling the requests of so many patrons is no easy task but Dolly and Dennis have been in contact with those impacted and is working to mitigate inconvenience. An observant harbor user will also notice Admiralty Construction working at the north of Aurora Harbor to replace water service connections and retaining wall which is part of the Aurora Harbor rebuild project. We will continue to provide updates to this very important project scheduled to be substantially compete on May 31st, 2015.

The end of the 2014 season also provide us the opportunity to review our management procedures for the downtown Cruise Ship Terminal areas and the Statter Harbor operations. The meetings will allow patrons to meet and provide recommendations for increased efficiencies. The Cruise Ship Terminal area end of year brief will be held on Friday, September 19th at 9 am in the Assembly Chambers. The Statter Harbor end of year brief will be at the Mendenhall Library on September 24th at 5 pm. Harbor patrons, commercial operators and others are welcome to attend the meetings.

Docks & Harbors has also been responding to Aurora Harbor residents who have observed increased winter ice formations over the past few seasons. Upon research by Deputy Port Engineer Erich Schaal, it was discovered that a sediment vault which collects storm water coming off Mt Juneau required maintenance. The sedimentation was diverting the fresh water run into the harbor and away from the conduit carrying the water into Gastineau Channel. The fresh water was freezing, impacting the boats in the harbor.

North Douglas Launch Ramp - We are in the process of negotiating asphalt repairs to the North Douglas Launch facility with SECON. We will work to minimize the impact to launch patrons but please be aware that there may be times that the ramp will be unavailable this fall. Please watch for signs with the closure dates.

Comprehensive Fee Review: The Docks & Harbors Board is in the process of reviewing all fees associated with CBJ regulations. The Board will convene two committees, one will review the Docks Enterprise fees and one will review the Harbor Enterprise fees. The Docks Fee review committee will meet at 7 pm on Wednesday, September 17th in the CBJ Assembly Chambers. The meeting for the Harbor fees will be Thursday, September 18th following the scheduled Docks & Harbors Operations-Planning Committee in the Assembly Chambers.

Safety Tip As the days begin to darken and the wind becomes a bit more chilly, boating safety is as important as ever. The best way to protect against potentially adverse weather conditions is to be prepared. It is important to have onboard your vessel at all times: lifejackets, communication devices, distress signals, navigation tools, a re-boarding device (foot sling or ladder), first aid kit, food, water, warm clothes, and more! You should check the marine forecast anytime you plan to go out on the water, and file a detailed float plan with a responsible adult who can report you as missing if you do not return as scheduled. The **Alaska Office of Boating Safety** has several tools to help you be more prepared on the water. Planning tools include weather and tide reports, a life jacket selector, a pre-departure checklist, and a comprehensive electronic float plan that you can file quickly and easily on their website at <u>http://pledgetolive.org/</u>.
