

# Seasonal Vendor Permit Certificate of Compliance Completion Instructions

CBJ Code 62.10.050 (i) and 62.10.070 (h) states the following:

"...Prior to issuance, the applicant shall submit to the manager a certification by the finance department that the applicant has met the requirements of the sales tax code..."

The applicant must have this certification completed by the CBJ Finance department before a vending permit can be issued by CBJ Community Development.

### **CBJ Finance Division Contacts**

- Assessor-BPP: The Business Personal Property Appraiser located in the CBJ Assessor's office will
  check if all required filings have been submitted. The Assessor's office is located in room 114 of City
  Hall
- Sales Tax: The Sales Tax office will verify that the applicant is registered, that all required returns have been filed and that all sales tax, late fees, penalties & interest have been paid in full. The Sales Tax office is located in room 106 of City Hall.
- **Treasury:** The CBJ Treasury / Collections office will verify that all property taxes have been paid and that there are no other taxes, fees or assessments due to CBJ. The Collections office is located in room 105 of City Hall.

- **Business Name:** Please provide the name of the business that will be operating under the Vending Permit.
- Alaska Business License: The business's current State of Alaska business license number must be provided.
- **Type of Organization:** Please check the appropriate box for the type of business organization.

  physical location of the vending cart or vending activity for which the permit will be issued. If actual
  street address is not available, the location description will be sufficient.
