Hi Jessie,

Regarding federal subsistence permits issued in that proposed annexation zone from 2012-2017, the answer is indeed "none issued". The only federal subsistence permits issued would be for designated hunters. Dennis Chester had issued about one of these every year or so, but even if it was for the man who lives over on the Mansfield Pen year-round, the address listed would've been for Juneau. There would be no address written on the permits that would fall within that red zone, nor would the harvest have to take place in that specific an area. So... if they are simply defining "subsistence activities" in that areas as the issuance of federal permits, I have verified with Derek Hildreth (USFWS) at the Office of Subsistence Management that no permits were issued there during those years. Now, that man who lives on the island qualifies as a subsistence hunter and is thus able to fill all 5 tags ADFG gives him... and has a longer season in which to do it. However, there is no way to track the *subsistence* harvest of deer.

I've cc'ed Justin Koller in case I have this wrong or he'd like to add anything.
