Hi Megan – Clarifying some things following our call last week and our FOIA coordinator’s message I forwarded you on Friday...so in my reporting system, I can’t burrow down to individual bays. Our use reporting system reports out by Guide Use Area (GUA) (see map). So the annexation area would be within GUAs 01-05, 04-08, 04-09, 04-10.

I ran a use report for 2012-2017 for those areas, took the company names and then tallied based on number of boats they operated and where they go (assuming they’ll be getting provisions at most/if not all the port stops they visit).
