V. INFORMATION ITEMS

- Climate Change Impacts and Mitigation – Jim Powell and Duff summarized a meeting with UAS regarding update of Climate Predictions report that was written in 2007. Assembly member Carole Triem attend the meeting. Ideas were:
 - an interest in updating the report,
 - some indicators to help measure, and
 - to explore having an energy research center in Juneau. This last item is conceptual at the moment. Would need funding from Fed Gvt, Manufacturers
- Officers –

Duff Mitchell was concerned that there is a perception that his role as Chair can be misconstrued as being to biased toward Juneau Hydropower activities. Duff gave summary of role of Chair including the time commitment. Gretchen Keiser also stated that they are there to invigorate the Chairs of sub-committees.

Jim Powell made motion to support Duff as Chair. Jim Rehfeldt 2nd. Ed King objected for the purpose of asking if anyone else was interested. Jim Rehfeldt was happy to get in line for future years but was not interested in this year. Everyone was in favor – motion passed.

Jim Rehfeldt offered to be vice-chair. Motion by Iura, 2nd by Duff. No objection

Jim Powell suggested Tim Felstead's staff time be dedicated to other JCOS activities and that a member could fill the secretary role. Gretchen suggested to rotate it. Christine Woll stated she would be happy to do it. Steve Behnke made motion for Christine Woll. Gretchen 2nd. No objection.

Climate/Energy – Implementation of JCAIP/JRES – Steve (Chair), Gretchen, Jim Rehfeldt

- Electrification of transportation (Dock electrification, and ground transportation including EV charging/VW grant)
- Electrification of space heating with heat pumps – nexus with affordable housing
- CBJ Energy Management – CBJ leading CBJ including fleet/Capital Transit vehicles/monitoring/building improvements
