### **INFORMATION ITEMS**

### A. EAGLECREST PRESETNATION – Requested by E. Palmer

At the Committee's request, we have invited Eaglecrest General Manager Dave Scanlan to attend today's meeting. The Committee expressed an desire to identify opportunities for collaboration between Eaglecrest and the Parks & Recreation Department. Mr. Scanlan will also present information on Eaglecrest's summer development plans.

### **B.** Land Disposal Process Update – Requested by the Committee

The Committee previously requested an update regarding (1) a request from John and Ginger Bean to purchase park land in the Montana Creek area, (2) how proceeds from the sale of park lands are used, and (3) the process to evaluate similar requests in the future. The attached memo provides an update on these topics.

### C. 2019 Day of Play – Requested by L. Verrelli

Each year the Parks & Recreation Department opens our facilities to the community for a free "Day of Play." This event annually attracts nearly 750 people to our parks, pools, the Zach Gordon Youth Center, and Treadwell Ice Arena. RE:	Land Disposal Process and Bean Property Purchase Request Update

On June 4, 2019, Lands & Resources staff presented a request by John and Ginger Bean to purchase a park parcel at the corner of Slim Williams Way and Arctic Circle. The Committee requested additional information from Parks and Recreation staff regarding a public process for input from the nearby landowners on the potential sale, the proceeds from the sale of parkland, and process for disposal of parkland.

**Status of Bean Request and Public Notification:** Since the June 4<sup>th</sup> PRAC meeting, we have worked with the Community Development Department and the Law Department to evaluate this request. Preliminary research indicates that this parcel was designated as a public park as part of the platting process that created the subdivision. This raises significant questions about whether the parcel can be sold to the adjacent landowner. Additional research is required, and we will continue to update the Committee as more information is available. If it is determined that the land can be sold to the owner, we will work with the Community Development Department and the Lands & Resources Office to conduct a robust public process, including notification and a community meeting. The proposal would come back to PRAC after that public process.

**Revenue from Land Sales:** The Committee previously requested information regarding whether the proceeds from the sale of park lands could be dedicated for the acquisition of new land for parks, and/or the maintenance and improvement of parks.

Existing code requires that all proceeds from the sale of municipal lands (including parks) shall be credited to the Land Fund (CBJ 53.09.600), and may not be dedicated to another purpose at the time of sale:

(a)The revenue from all disposals of land, interests in land, or resources under this chapter shall be credited to the account of the municipal land fund, except the following:

(1)Revenues from the lease, sale or other disposal of land, interests in land, or resources which are accounted for as an asset held for a service area or for an enterprise operation, such as the airport, small boat harbors, transit system, Eaglecrest ski area sewer and water utilities, shall be credited to the account of the service area or enterprise; and (2)Proceeds from the sale of tax foreclosed land shall be distributed in accordance with applicable state law with any remainder being deposited in the fund.

While proceeds may not be restricted at the time a property is sold, the Land Fund may be used by the Assembly to acquire new park land. For example, property occupied by the Mendenhall River and Montana Creek trail systems was acquired using partial funding from the Land Fund.

If the CBJ established a Parks & Recreation Service District, then proceeds from land sales could be restricted to that account.

**Process for disposal of parkland:** The 2019-2029 Parks & Recreation Department Master Plan provides guidance for considering requests to dispose of park lands. Working with other CBJ departments since the June 4<sup>th</sup> PRAC meeting, we have refined the process to consider such requests. This improved process will require close coordination with the Community Development Department and Lands & Resources Office, and would be adopted as a departmental policy:

- 1. The process begins when an application to purchase CBJ land is received by the Lands & Resources Office, along with the required fee.
- 2. Parks & Recreation staff will review the application with other affected departments, including Community Development and Law, if necessary.
- 3. The Community Development Department will review the application to consider relevant codes and area plans.
- 4. The Community Development Department will work with Parks & Recreation to receive public comment on the application. Public notice may include mailing flyers to nearby property owners, media advertisements, signage, and a public meeting.
- 5. After public comment has been received, the PRAC will review the application and provide a recommendation to the Department and the Assembly.
- 6. The Planning Commission will review the application, if required, and provide a recommendation to the Assembly.
- 7. The Lands Committee will review the application, if required, and provide a recommendation to the Assembly.
- 8. The Assembly will consider the application and decide whether to retain or dispose of the property.
