RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A Resolution Accepting the Fiscal Year 1999 Municipal Capital Matching Grants.

WHEREAS, the State of Alaska has established the Municipal Capital Project Matching Grant Program under AS 37.06, and

WHEREAS, the State of Alaska Department of Administration has made available under this program six grant projects for a total of \$512,048, and

WHEREAS, the City and Borough of Juneau has agreed to contribute a total of \$219,449 as its share of these projects;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

Section 1. Municipal Capital Project Matching Grant Projects. The following is a list of the Municipal Capital Project Matching Grants to be made available by the State of Alaska to the City and Borough of Juneau under AS 37.06, including for each project the local share which the city and borough has agreed to contribute in the form of a cash contribution:




Section 3. Effective Date. This resolution shall be effective immediately upon adoption.
