RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 2557

A Resolution Expressing the Assembly's Support, and Intent to Provide Maintenance and a Local Match, for Projects That are Being Considered for Inclusion in the Alaska Department of Transportation and Public Facilities Statewide Transportation Improvement Plan.

WHEREAS, the Alaska Department of Transportation and Public Facilities (ADOT/PF) regularly considers projects for inclusion into the Statewide Transportation Improvement Plan (STIP); and

WHEREAS, the inclusion of local projects into the ADOT/PF STIP benefits the CBJ with the opportunity for local projects to be completed with State funding; and

WHEREAS, the local support can improve scoring of some projects; and

WHEREAS, municipalities that agree to provide matching funds and maintenance can improve the scoring of some projects; and

WHEREAS, under ADOT/PF Policy 09.01.040, local governments can be required to provide the federal aid highway match fund, which is 9.03 percent of the total project cost; and

WHEREAS, supporting the following high priority projects at the listed level of support would benefit the community:

Glacier Highway Pedestrian Improvements (WalMart to Anka)
North Douglas Pedestrian and Bicycle Improvements

Resolution of Support, Maintenance of New Facilities

North Aurora Harbor Vehicle and Pedestrian Access Improvements
Egan Drive - Harbor Area Intersection Improvements

Resolution of Support, 50 Percent Match and Maintenance of New Facilities

50 Percent Match - Governor's House Area Roads: Distin Avenue, W. Eighth Street and Indian Street

Resolution of Support, 9 Percent Match and Maintenance of New Facilities

Under Thunder Trail
Treadwell Ditch Trail
Capital Transit Downtown Circulator (Purchase 5 Care-A-Van sized electric coaches)
Expanded Operations Facility for Capital Transit
Mendenhall Valley Transit Center
Lemon Creek Pedestrian Bridge; and

WHEREAS, ADOT/PF requires a CBJ resolution to commit the match funds; and

WHEREAS, the required CBJ match can be funded in future fiscal years, through operating budgets and the Capital Improvement Program.

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:


