## RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

### **A Resolution Expressing Support for the Juneau Coordinated Transportation Coalition's Prioritization of Projects for Grant Funding by the Alaska Department of Transportation & Public Facilities.**

WHEREAS, the City and Borough has adopted the 2008 Transit Development Plan: Coordinated Human Services Element to identify available transportation services and to lay out strategies to address gaps in transportation services provided those who are elderly, have disabilities, or who qualify as low-income and use public transportation for traveling to and from work; and

WHEREAS, the Alaska Department of Transportation & Public Facilities makes available grant funding for mobility projects; and

WHEREAS, in order to be considered for grant funding, each community must prioritize the projects seeking funding and that priority list must be endorsed by the local government; and

WHEREAS, the Juneau Coordinated Transportation Coalition is a coalition of community partners working to improve the effectiveness and efficiency of transportation in Juneau; and

WHEREAS, one of the Coalition's main roles is to rank funding requests from member agencies proposing transportation and mobility projects and submit those recommendations to the Assembly; and

WHEREAS, the Juneau Coordinated Transportation Coalition and related agency representatives held a Community Transportation Needs Assessment meeting on November 6, 2014, and voted on the priority list for FY 16 DOT&PF grant funding as follows:

1. Dialysis Transportation (Purchase of Services)
2. Taxi Voucher (Purchase of Services)
3. Lift-equipped taxi (Capital); and

WHEREAS, as requested by DOT&PF, these three projects were also prioritized by project type (capital and non-capital) as follows:

Purchase of Services:

1. Dialysis Transportation
2. Taxi Voucher

Capital:

1. Lift-equipped taxi.

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

**Section 1.** The City and Borough endorses the following prioritized list to be considered for Alaska Department of Transportation and Public Facilities grant funding:

1. Dialysis Transportation (Purchase of Services)
2. Taxi Voucher (Purchase of Services)
3. Lift-equipped taxi (Capital); and

Purchase of Services:


1. Dialysis Transportation

Capital:


1. Lift-equipped taxi.
