RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 1873

A Resolution Establishing a Shooting Range Advisory Committee.

WHEREAS, firearm safety in the city and borough would benefit from the creation of a shooting range advisory committee;

Now, Therefore, Be it Resolved by the Assembly of the City and Borough of Juneau, Alaska:

Section 1. Committee Established. There is established the City and Borough of Juneau Shooting Range Advisory Committee. The committee shall consist of six members serving two-year staggered terms; provided that the terms of the initial committee members shall be as follows:

(a) Three members shall be appointed for one-year terms, and

(b) Three members shall be appointed for two-year terms.

Section 2. Appointment. The members shall be appointed by the Assembly upon nominations as follows:

(a) Two nominations shall be submitted by the President of the Territorial Sportsmen, Inc. Of those initially nominated, one shall be for a one-year term and one shall be for a twoyear term. The President of the Territorial Sportsmen, Inc., may appoint two alternate members to serve during the absence of the regular members.

(b) Two nominations shall be submitted by the President of the Juneau Rifle and Pistol Club. Of those initially nominated, one shall be for a one-year term and one shall be for a two-year term. The President of the Juneau Rifle and Pistol Club may appoint two alternate members to serve during the absence of the regular members.

(c) Two nominations shall be submitted by the President of the Hank Harmon Rifle Range, Inc. Of those initially nominated, one shall be for a one-year term and one shall be for a two-year term. The President of the Hank Harmon Rifle Range, Inc., may appoint two alternate members to serve during the absence of the regular members.

Section 3. Qualifications. Nominees and alternates shall have experience with hunting, organized competitive shooting, recreational shooting, or military or law enforcement service involving firearms, and shall have demonstrated enthusiasm for the shooting sports. Nominees or alternates may serve on the board of directors of Hank Harmon Rifle Range, Inc.

Section 4. Committee Purposes. The purpose of the committee shall be to:

(a) advise and assist the Assembly and the Manager on matters of range policy,

(b) recruit and appoint a caretaker qualified to open, close, and monitor the Hank Harmon Rifle Range. The Manager upon recommendation of the committee may negotiate and execute an agreement for residential use by the caretaker of CBJ land in the vicinity of the range in exchange for caretaker services, and

(c) inquire into the costs and benefits of establishing an indoor range.

Section 5. Rules of Procedure. The rules of procedure for Assembly advisory committees as established by Resolution Serial No. 1180, as amended by Resolution Serial No. 1213, shall govern the conduct of business of the committee.

Section 6. Staff Assistance. Staff support and assistance to the committee shall be provided by the Facilities Director of the Department of Parks and Recreation.

Section 7. Meetings. The committee shall meet at least quarterly.

Section 8. Committee Recommendations. The committee will present its initial recommendations for range policy to the Assembly by January 1, 1998, and will present updated annual reports on the implementation of the recommendations and further recommendations as appropriate.

Section 9. Expiration of Committee. The committee shall be abolished effective July 1, 1998, unless extended by the Assembly by resolution. By no later than June 1, 1998, the committee shall submit a written report to the clerk making a recommendation to the Assembly on whether the committee should continue to exist.

Section 10. Effective Date. This resolution shall be effective immediately upon adoption.
