A RESOLUTION APPROVING A GRANT AGREEMENT AND AUTHORIZING THE EXECUTION THEREOF; SUCH GRANT BEING A GRANT FROM THE FEDERAL AVIATION ADMINISTRATION IN THE AMOUNT OF \$535,313 FOR THE RECONSTRUCTION OF INTERSECTION "A"; A NEW GROUND-LOADING GATE 6; PAVING OF RENSHAW WAY; OVERLAY OF ALEX HOLDEN WAY; PAVING OF A SECTION OF OLD CESSNA DRIVE; PAVING OF A SECTION OF THE CIVIL AIR PATROL FLOAT POND ACCESS ROAD; A REPLACEMENT SECURITY VEHICLE; A REPLACEMENT SECURITY BADGING SYSTEM FOR THE JUNEAU INTERNATIONAL AIRPORT; AND, AS ADDITIVE ALTERNATES, CONSTRUCTION OF THE ALEX HOLDEN AND RENSHAW WAY WATER LINES AND THE EAST HANGAR SITE WATER LINE.

WHEREAS, the City and Borough of Juneau, Alaska, has submitted an application to the Federal Aviation Administration (FAA) for a grant pursuant to the Airport and Airway Improvement Act of 1982 to aid in the financing of certain airport improvements identified as Project No. 3-02-0133-10, and

WHEREAS, the FAA has approved the grant application, and

WHEREAS, the Assembly of the city and borough approves the grant and authorizes the expenditure of the grant funds and any required local matching funds, and

WHEREAS, it is necessary and in the public interest to undertake the airport improvements to be financed by this grant;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. Approval of Grant Agreement. That the grant agreement from the FAA in the amount of \$535,313 for the reconstruction of Intersection "A"; a new ground-loading Gate 6; paving of Renshaw Way; overlay of Alex Holden Way; paving of a section of old Cessna Drive; paving of a section of the Civil Air Patrol float pond access road; a replacement security vehicle; a replacement security badging system; additive Alternate No. 1, construction of the Alex Holden and Renshaw Way water lines; and additive Alternate No. 2, the east hangar site water line, at the Juneau International

Airport is hereby approved in all respects and is incorporated herein by reference as if fully set forth herein. The manager is authorized to execute the grant agreement and to make such assurances and agreements as are necessary to enter the grant agreement and carry out its terms. The manager or the manager's designee or such other officer as is required by law or regulation is authorized to do such acts as are required in connection with the execution of the grant agreement and the performance of its terms; further, the manager or the manager's designee is authorized to execute such requisitions as may be required for payment from the FAA of funds pursuant to the grant agreement.

- 2. Project Funding. Funding for this project, identified as Project No. 3-02-0133-10, is to be provided by the Airport Enterprise Fund in the amount of \$31,169; the State of Alaska Department of Transportation and Public Facilities in the amount of \$31,168; and the U.S. Department of Transportation, Federal Aviation Administration in the amount of \$535,313.
- 3. <u>Effective Date</u>. This resolution shall be effective immediately upon adoption.
