A RESOLUTION AMENDING RESOLUTION SERIAL NO. 462, AS AMENDED, TO ESTABLISH FEES FOR THE USE OF AIRPORT PROPERTY BY VEHICLES PROVIDING GROUND PASSENGER TRANSPORTATION FOR COMMERCIAL PURPOSES.

WHEREAS, by Resolution Serial No. 462, as amended by Resolution Serial Nos. 583, 598 and 695, the assembly has established miscellaneous fees and charges for use of the Juneau International Airport, and

WHEREAS, all private parties and corporations that use the airport for commercial purposes should share in the cost of the operation of the airport, and

WHEREAS, taxicabs, airport shuttle service vehicles, sightseeing vehicles, courtesy cars and other ground passenger transportation vehicles use the Juneau International Airport for commercial purposes and should contribute to the cost of operating the airport just as others who benefit from the commercial use of the airport contribute to the operating expense of the airport,

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

- 1. That Resolution Serial No. 462 is amended by adding a new subsection 1(e) reading:
 - (e) Commercial Ground Passenger Transportation Vehicle Fees
- (1) Commercial ground passenger transportation vehicles, including, but not limited to, courtesy vehicles, taxicabs, airport shuttle service vehicles, and sightseeing vehicles, except those owned and operated by a governmental entity, shall display an airport ground passenger transportation vehicle permit prior to entering upon the property of the Juneau International Airport for the purpose of picking up or discharging any person for commercial purposes. "Commercial purposes" includes transportation of persons to or from the airport without charge by a motel, hotel, rental car agency or other business that either advertises or regularly provides such services in connection with its business; it also includes transportation to or from the airport for a fee for any purpose.
- (2) Permits shall be issued by the airport manager on a calendar year basis. A permit shall be issued upon the payment of the fee set out in this subparagraph and the signing of an agreement regulating the applicants use of airport property. Fees shall be:

Permits issued after January 31 of a year may be prorated on a monthly basis rounded upward to the nearest number of months remaining in the year but shall not be reduced to less than one-half the annual fee.

2. This resolution shall become effective on July 1, 1984.
