RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION REQUESTING THE ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES (DOT/PF) TO PERMIT THE CITY AND BOROUGH OF JUNEAU TO ASSUME THE DEPARTMENT'S RESPONSIBILITIES RELATING TO THE STEPHEN RICHARDS DRIVE SAFETY LANES, MENDENHALL BOULEVARD SAFETY LANES, JUNEAU AREAWIDE STREET IMPROVEMENTS, AND BARTLETT MEMORIAL HOSPITAL PATIENT WING PROJECTS.

WHEREAS, the legislature has appropriated to DOP/TF \$160,000 for the Stephen Richards Drive safety lanes project, \$60,000 for the Mendenhall Boulevard safety lanes project, \$1,400,000 for the Juneau areawide street improvements project, and \$1,000,000 for the Bartlett Memorial Hospital patient wing project, and

WHEREAS, AS 35.15.080 provides that a municipality may, upon the concurrence of the commissioner of DOT/PF, assume the department's planning and construction responsibilities for public works projects of the state which are located within the municipality, and

WHEREAS, the City and Borough of Juneau has the authority to receive and expend such funds and to contract for such work, and

WHEREAS, the City and Borough of Juneau desires to assume the department's responsibilities for the work;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:


1. That, pursuant to AS 35.15.080, the commissioner of the Department of Transportation and Public Facilities is requested to execute one or more agreements with the City and Borough of Juneau which provide for the assumption by the city and borough of the department's responsibilities relating to the work to be accomplished under the DOT/PF-Juneau Stephen Richards Drive safety lanes project, the Mendenhall Boulevard safety lanes project, the Juneau areawide street improvements project, and the Bartlett Memorial Hospital patient wing project.

2. That upon the execution of an agreement, the city and borough shall assume responsibility for the administration of the project and the funds.

3. That the manager of the City and Borough of Juneau or his designee shall be the coordinator for each project. Further, the manager is authorized to execute necessary agreements and to do all things necessary to comply

with the lawful requirements of the department including, without limitation,  
the designation of a project coordinator.
