RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION AMENDING RESOLUTION SERIAL NO. 963, AS AMENDED BY RESOLUTION SERIAL NOS. 978 AND 998 TO CHANGE THE METHOD OF COMPUTING OFF-SITE ASSESSMENTS FOR WATER SYSTEM CONNECTIONS.

WHEREAS, under Resolution Serial No. 963, as amended, the assembly made a comprehensive change in the charges and fees for water service, and

WHEREAS, upon further consideration it has been determined that the off-site assessment for large diameter connections that are sized primarily to provide fire protection should be reduced;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

- 1. That Section C(1) of Resolution Serial No. 963, as amended, is further amended to read:
- (1) Ordinary Demand. Every applicant for new water service to property which abutts a water main shall pay, for each connection requested, the following charges which cover the cost to the municipality of making the connection, installing a water meter, as well as the share of the connecting property's cost of the plant necessary to produce and deliver domestic use water, but not fire protection use water, to the property. The assessment shall be as follows:
 - (a) 3/4 inch diameter service

\$ 750

(b) 1 inch diameter service and larger

\$1,500 plus \$750 for each 1/2 inch over 1 inch, rounded up to the nearest 1/2 inch. (c) Lines sized for sprinkler service The greater of \$750 or the actual cost cost of the connection, including any meter and remote readout.

2. Paragraph E of Resolution Serial No. 963, as amended is amended to read:

E. METERS.

Meters shall be installed for all service except:

- (1) Residential service to four or fewer residential units unless requested by the customer,
- (2) Fire protection service lines not used in any manner for unmetered domestic supply unless requested.

Each domestic supply taken from a fire protection service line shall be metered and shall be charged the appropriate off-site assessment set out in paragraph C(1)(a) or (b).

The property owner shall provide a place for installation of the meter that is acceptable to the utility. The meter must be located in an area that is heated, dry, and accessible for repair and replacement of the meter, as determined by the utility. A shut off valve shall be installed by the property owner ahead of the meter yoke. The utility may install a remote readout; a suitable place for the remote unit shall be provided by the owner and shall be satisfactory to the needs of the utility.

- 3. Paragraph F(1) of Resolution Serial No. 963, as amended is amended to read:
 - (1) Metered Water Service.

The monthly charge for the first 4,000 gallons or any part thereof is \$13.00; for each 1,000 gallons, rounded to the nearest 1,000 gallons, in excess of 4,000 an additional charge of \$1.50 shall be paid. For any property upon which the utility has installed more than one meter, each meter shall be read and billed to the owner of the property as if it were a separate service.

4. Effective Date and Refund. This resolution shall be effective retroactive to September 1, 1983. The difference between the cost of a connection under the rates established under this resolution and the cost paid under the rates established by Resolution Serial No. 978, adopted September 1, 1983, shall be refunded without interest to the current owner of the property to which the connection was made.
