A RESOLUTION HONORING POLICE CHIEF JOSEPH RONALD CIRAULO.

WHEREAS, Chief Joseph Ronald Ciraulo, once nicknamed "Peppy," came to work for the City of Juneau in July of 1962 after being honorably discharged from the U. S. Coast Guard where he was the officer in charge of a patrol boat protecting this nation.

WHEREAS, Chief Ciraulo has served the people of Juneau for 23 years and, during that period, was promoted from patrol officer to detective, to sergeant, to lieutenant, to captain, and was appointed chief in September of 1980. Throughout his law enforcement career, his consistently excellent performance is recorded with written comments from his supervisors such as:

Chief Ciraulo has set a tone of soft-spoken professionalism for the Juneau Police Department. WHEREAS, under Chief Ciraulo's leadership, no officer has been seriously injured and every law enforcement emergency has been handled quickly and competently.
