RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION ESTABLISHING THE CITY AND BOROUGH OF JUNEAU'S
CAPITAL IMPROVEMENT PROJECT PRIORITIES FOR FISCAL YEAR 1988.

WHEREAS, the City and Borough of Juneau annually prepares a comprehensive capital improvement program for the city and borough, and

WHEREAS, the State of Alaska annually prepares a capital improvement program and appropriates funds to local governments and state agencies for the implementation of local and state capital improvement projects, and

WHEREAS, the Assembly, based upon extensive study and review of the projects and issues conducted by the Assembly's Capital Improvement Projects Committee, has determined certain capital improvement project priorities for the city and borough for Fiscal Year 1988;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

A. That the following projects, set forth in order of priority, are established as the city and borough's top priorities for capital improvement projects for Fiscal Year 1988:

1.	Community-Wide Water System	6,000,000
2.	UAJ Library	2,800,000
3.	Wastewater Treatment Plant Construction and Appurtenant Work	1,900,000
4.	School Repairs	400,000
5.	Street Improvements	3,000,000

6.	Second Channel Crossing, Environmental Impact Study	400,000
7.	Harbor Improvements	750,000
8.	Airport Improvements	325,000

B. That the following projects, not set forth in order of priority, are established as additional capital improvement project priorities for the city and borough for Fiscal Year 1988:

	<u>Project</u>	<u>Estimated Cost</u>
1.	Community-Wide Water System	3,200,000
2.	Sewer System Repairs	700,000
3.	Drainage, Phase I	1,000,000
4.	Swimming Pool Tank Replacement	800,000
5.	Regional Trade Center Analysis	250,000
6.	School Repairs	300,000
7.	Riverside Drive, Phase II Construction	2,000,000
8.	Extension of North Douglas Highway	4,000,000

C. That this resolution shall become a part of the City and Borough of Juneau's Capital Improvement Project Grant Request for Fiscal Year 1988 to be submitted to Governor Cowper, Juneau's legislative delegation, and appropriate departments and agencies of the State of Alaska.

Effective Date. This resolution shall be effective immediately upon adoption.
