RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION AUTHORIZING THE MANAGER TO SUBMIT TO THE STATE OF ALASKA, DEPARTMENT OF COMMUNITY AND REGIONAL AFFAIRS, AN APPLICATION FOR A \$10,000 GRANT THROUGH THE EMERGENCY SHELTER GRANT PROGRAM TO BE USED BY THE JUNEAU COOPERATIVE CHRISTIAN MINISTRY, D.B.A. THE GLORY HOLE, A NONPROFIT CORPORATION, TO FURTHER ITS PROGRAM IN PROVIDING EMERGENCY SHELTER TO JUNEAU'S HOMELESS PEOPLE.

WHEREAS, grant funds are currently available to local governments through the Emergency Shelter Grant Program for projects which provide emergency shelter for the homeless, and

WHEREAS, such grants may be further distributed by local governments to eligible providers of services for the homeless, and

WHEREAS, the Alaska Department of Community and Regional Affairs administers this grant program, and

WHEREAS, the Juneau Cooperative Christian Ministry d.b.a. The Glory Hole, provides services for the homeless in Juneau, and

WHEREAS, The Glory Hole has submitted to the city and borough an application requesting that the city and borough apply for a \$10,000 grant through the Emergency Shelter Grant Program to be used by The Glory Hole for building maintenance, utility costs, mortgage and insurance costs, furnishings, equipment, and food, and

WHEREAS, The Glory Hole has demonstrated its ability to provide the required supplemental matching funds, and

WHEREAS, the Assembly has reviewed the grant application prepared by The Glory Hole, and

WHEREAS, the city and borough will comply with federal and state laws and regulations applicable to the Emergency Shelter Grant Program, and WHEREAS, this resolution was reviewed by the Assembly Health and Social Services Committee which recommended that it be approved by the Assembly;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. Authority to Submit Grant Application. The Assembly hereby authorizes the manager to submit an application to the State of Alaska, Department of Community and Regional Affairs, for a grant in the amount of \$10,000 through the Emergency Shelter Grant Program to be used by the Juneau Cooperative Christian Ministry, d.b.a. The Glory Hole, to further its program of providing emergency shelter to Juneau's homeless people.

2. Administration of Grant. The city and borough department of health and social services is established as the agent for the city and borough for the administration of this grant.

3. Effective Date. This resolution shall be effective immediately upon adoption.
