RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION CREATING AN ALCOHOLISM ADVISORY  
BOARD FOR THE CITY AND BOROUGH OF JUNEAU,  
ALASKA.

WHEREAS, the Assembly of the City and Borough of Juneau, Alaska, has recognized alcoholism and alcoholism rehabilitation as a primary health concern in Juneau, and

WHEREAS, the Charter of the City and Borough of Juneau specifically cites the need for an alcoholism advisory board to recommend changes in local ordinances which will emphasize treatment of alcoholism as a social disease rather than a crime, and

WHEREAS, state and federal alcoholism and drug abuse programs contemplate a local advisory board, appointed by the City and Borough Assembly, as the advisory body for various aspects of particular projects.

NOW, THEREFORE, BE IT RESOLVED:

1. An Alcoholism Advisory Board is hereby created in the City and Borough of Juneau, Alaska. Such board shall initially be composed of the same people and for the same terms as previously created under Ordinance Serial No. 74-25.
2. The purposes of the advisory board are:
  - a. As a priority matter, to formulate specific recommendations to the Assembly and to the City and Borough Manager on municipal legislation, policies and programs which emphasize treatment and prevention of alcoholism and public drunkenness rather than imprisonment or levy of fines.


- b. To serve as the advisory body in development of the Juneau Coordinated Alcoholism Rehabilitation Project.
- c. To consult with the director of the alcoholism program in matters pertaining to data collection, research, agency coordination planning, program development, project formulation, facilities and budget as it relates to alcoholism, public drunkenness, drug abuse and other similar and related health and social problems.
- d. To promote public education in its field of concern.
- e. To carry out other functions as are designated by the Assembly.

3. Administration, staffing and budget services required to fulfill the purposes described in paragraph 2 above shall be provided by the City and Borough through the office of the City Manager.


4. There shall be no fewer than seven members of the Alcoholism Advisory Board, who shall be appointed by the Assembly. Each member shall serve for two years. Members of the board shall be selected who have demonstrated a concern with alcoholism and similar and related problems, who express a willingness to contribute time to advise concerning a comprehensive treatment program, and who reflect the distribution of socioeconomic and ethnic groups in the City and Borough.

5. The Alcoholism Advisory Board shall adopt by-laws providing for meetings, standing committees, if any, and for such other matters as may be appropriate. The by-laws shall become effective only after approval of the Assembly, which may accept, reject or modify in whole or in part and accept such by-laws.
