NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That the City and Borough of Juneau hereby accepts the offer of the grant of \$192,621 for the state's share of eligible costs incurred and to be incurred in the above projects.

2. That the manager is authorized to submit revised grant applications for additional funding by the state of the above projects under AS 46.03.030.

3. That the City and Borough of Juneau hereby tenders its acceptance of additional grants for the above projects where such additional grants are offered under substantially the same conditions as the grant herein accepted.

4. That the manager of the City and Borough of Juneau is hereby authorized to do all acts necessary to draw on such grant funds, to accept such funds on behalf of the City and Borough of Juneau, to make available to the State of Alaska such records as are necessary to document project expenditures, and to do such other acts as are necessary to comply with eligibility requirements established by the state.

5. That the City and Borough of Juneau will maintain an adequate accounting system to the end that a project audit will clearly identify each expenditure.

6. That the City and Borough of Juneau agrees to provide sufficient funds to assure completion of each of the above-named projects as federal and state funds are available.
