RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION DECLARING THE FORFEITURE OF THE OFFICE OF ASSEMBLYMAN BY LENARD (LEN) SEVDY ON THE GROUNDS THAT HE IS NOT QUALIFIED BECAUSE HE IS AN ASSEMBLYMAN WHO HOLDS OTHER COMPENSATED MUNICIPAL EMPLOYMENT.

WHEREAS, in the regular municipal election held on October 7, 1975, Lenard (Len) Sevdv was elected to the office of assemblyman from District 3 of the City and Borough of Juneau, and

WHEREAS, the results of said election were certified by the assembly of the City and Borough of Juneau on October 14, 1975, and

WHEREAS, on October 23, 1975 Lenard (Len) Sevdv demanded he be sworn in and seated as assemblyman, and

WHEREAS, on October 23, 1975 the assembly, without waiving its right to later determine the qualifications of Mr. Sevdv to continue to hold office, seated Mr. Sevdv, and

WHEREAS, Mr. Sevdv was in the employment of the school board of the City and Borough of Juneau School District at and prior to his being seated on the assembly, and

WHEREAS, Mr. Sevdv has refused to voluntarily resign his position of employment with said school district, and

WHEREAS, Mr. Sevdv has, on, and after October 24, 1975 performed services for said school district, and

WHEREAS, Mr. Sevdv has accepted compensation from said school district for such services, and

WHEREAS, Mr. Sevdv has continued to occupy both a position as assemblyman and a position of compensated employment with the school district, and

WHEREAS, such position held by Mr. Sevdv with the school district is one of compensated municipal employment, and

WHEREAS, section 3.3(c) of the Charter of the City and Borough of Juneau prohibits an assemblyman from holding any other compensated municipal employment, and


WHEREAS, Len Sevdy is not qualified to hold the office of assemblyman because of his status as an employee of the school district of the City and Borough of Juneau subsequent to the assumption of his seat on the assembly;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. Lenard (Len) Sevdy is hereby declared to have forfeited his office of assemblyman under City and Borough Charter section 3.7(a)(1) and the seat to which he was elected is hereby declared to be vacant.

2. This resolution shall be effective upon adoption.
