RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 757

A RESOLUTION AMENDING RESOLUTION SERIAL NO. 464,
AS AMENDED BY RESOLUTION SERIAL NO. 580, ESTABLISHING
NEW FEES FOR THE USE OF THE SWIMMING POOL.

WHEREAS, it is necessary to increase fees for use of
the swimming pool in order to keep pace with increased cost
of operation;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF
THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That paragraphs 1 A, B, C, and D of Resolution
Serial No. 464, as amended by Resolution Serial No. 580,
are further amended to read as follows:

A. Admission Fees.

<u>Swim</u>	<u>Adult</u>	<u>Youth and Senior Citizen</u>
60-minute swims	\$ 2.50	\$.75
90-minute swims	3.00	1.00
Penny Saver	.75	.75

B. Pool Rentals.

<u>Number of Persons in Group</u>	<u>Hourly Rate</u>
0- 15	\$ 35.00
51-100	40.00
101-150	45.00
151-200	50.00

Minimum pool rental fees shall be the fee for one hour
at the applicable rate. After the first hour,
the fee may be incremented on a quarter hour basis,
each quarter hour or part thereof being charged at
one-fourth the applicable hourly rate.

C. Swimming Lessons:

Eight 60-minute lessons	\$17.25
Eight 30-minute lessons	11.50
Each additional hour	1.50

D. Monthly Tickets:

Tickets good for one calendar month or any part of a calendar month shall be available at the following rates:

Adult	\$30.00
Youth and Senior Citizens	15.00

Monthly tickets are non-transferable and no refunds for any reason may be made. The manager or his designee may prorate the monthly fee for any month during which there is a planned closure of the swimming pool.

2. That Resolution Serial No. 464, as amended by Resolution Serial No. 580, is amended by adding a new paragraph 1 G reading:

G. Youth Swim Team Rate.

The monthly rate for youth swim team use, not exceeding 40 hours per month, including swim meets, shall be \$300.00 per month. The times available for youth swim team use shall be determined by the manager or his designee. Use in excess of 40 hours per month shall be charged on a prorated basis determined by the manager.


3. That this resolution shall become effective on July 1, 1981.
