RESOLUTION OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS BETWEEN CERTAIN CAPITAL IMPROVEMENT PROJECTS.

WHEREAS, the City and Borough of Juneau received grants for capital improvement projects under Chapter 60 SLA 1981 (SB 168), and

WHEREAS, under Resolution Serial No. 779, the assembly established the projects to which it wished to apply said grant funds, and

WHEREAS, the assembly has appropriated local funds for certain capital projects, and

WHEREAS, it now appears necessary to change priorities and scheduling of certain projects which necessitate the transfer of funds among various projects;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

- That the manager is authorized to transfer the lesser of either the amount shown or the unobligated part of project funds as indicated among the following capital projects:
- Those funds not needed for the completion of A. the conceptual design phase of the new airport terminal (approximately \$700,000) shall be transferred from Project A-44.
- Up to \$117,500 shall be transferred from the East Plane Tiedown Project, A-38.
- C. Up to \$193,000 shall be transferred from the Terminal Apron Expansion Project, A-43.
- D. The funds transferred from the projects listed in A, B, and C shall be transferred to the Interim Terminal Improvements Project, A-48 (a/k/a A-40).

E. The funds in the amount shown are transferred from the following projects to the Municipal Buildings Roof Repair Project, D-47:
